2019 Request for CCF Non-Research Grant Proposals are now being accepted

Since 1983, The Children's Cancer Foundation, Inc. has invested in facilities, research, and programs that seek to improve the lives of children facing a diagnosis of cancer.

In addition to its annual research grants, CCF has regularly funded a variety of non-research requests. CCF welcomes innovative and meaningful proposals for Non-Research Grants that align with CCF's mission stated above.

The proposal should NOT exceed 3 (three) typed pages and should include:

- The amount requested
- An explanation of the Project or Item(s) requested
- Justification for the need for your requested Project or Item(s)
- Time frame (when Project or Item(s) will be started/completed)
- Budget for Project or Item(s)
- Signature of Department Head or other person(s) designated to approve grant requests

We ask that you include other sources from which you are seeking to fund the Project and any other funding source, and/or the amount contributed by your Institution/Hospital.

Requirements:

- The facility or program must exist or be held in the MD/D.C./N. VA region
- The project/program/service should be related to pediatric oncology
- A final report that includes the budget and an evaluation must be submitted within three months of the grant/project end date.

Proposals are due at 11:59 PM (EST) May 6, 2019.

Selection Process:

Recommendations for Non-Research Grants will be made in late June and presented to the full CCF Board of Directors for approval in July. Notification of funding will be communicated no later than August 2019. If your proposal is funded, CCF requires that you, or a representative of your organization, attend the CCF Gala on November 2, 2019 to receive the Grant Award.
