

## Impact: Funding Immunotherapy Research Offers Promise for Hard to Treat Lymphoma

Hodgkin Lymphoma and non-Hodgkin Lymphoma are now largely curable, but 10-20% of the time, it can be resistant to treatment and difficult to cure. When a young patient's cancer returns or does not respond to chemotherapy, it is often because the immune cells have become exhausted and are unable to recognize the cancer cells in the body.

For Dr. Dave's CCF-funded research, the first goal is to determine if a specific immunotherapy drug known as PD1 inhibitors, when given in combination with the administration of a particular immune cell (or T cell) therapy, will produce long-lasting cures with fewer side effects than conventional chemotherapy.

T cell therapy involves taking a patient's T cells and re-educating them in the laboratory to recognize

proteins on the cancer cells, and then give these T cells back to the patients so as to redirect the T cells to the cancer cells. A PD1 inhibitor is a newer immunotherapy drug that essentially releases the brakes on the immune system and allows the immune cells to become more effective in killing the cancer.

The second goal is to genetically modify the T cells to also become resistant to a chemical released by the cancer cells that inhibit the T cell's function.

This combination of immunotherapy treatments has the potential to benefit not only children with lymphomas, but other solid cancers such as neuroblastoma and brain tumors where the environment surrounding the cancer cells also makes it difficult for T cells to infiltrate and kill cancer cells.

# Creative Community Fundraising

While many fundraising events on behalf of CCF were cancelled, a few endured:

### **Giant Food Pediatric Cancer Fundraising Campaign**

Since CCF's inception in 1983, Giant Food has been raising funds to support our mission. For the last seven years, Giant Food has mobilized a regional fundraising drive for pediatric cancer research in their 163 local stores. Despite many shoppers who were financially impacted by the pandemic, the campaign broke records – more than \$2M raised in only five weeks. #### Virtual Recitals for Kettell Studio of Dance

Each year for the last 20 years, Jean Kettell, a dear friend to CCF's founder Shirley Howard, donates to CCF from revenue raised from her dance studio's recital including program book ads and ticket sales. Given that classes in 2020 were held online, the recitals were pre-recorded and then projected to a drive-in movie screen in October for all families to enjoy together.

CCF President Tasha Museles held a socially distanced check presentation with Jean Kettell at the CCF office.

#### **NECA-MD Golf Tournament**

After postponing a Spring golf event, NECA-MD hosted a socially-distanced Fall golf tournament. Eager to swing for a good cause, dozens of organizations sponsored golfers for an enjoyable day at Turf Valley, raising over \$40,000 for CCF.



## Race4ACure Charity Race

For the second year, local race enthusiast Bob Sommerville designated CCF as the recipient of funds raised by his non-profit Race4ACure. On September 22, he was able to include virtual runners and provided a staggered, socially-distanced in-person race.

## **CCF** Operations

For the first time, CCF found it necessary to fundraise specifically to cover operational costs. In addition to receiving an SBA PPP Loan in mid-2020, many generous donors assisted CCF, notably The Kahlert Foundation. We are incredibly grateful to these individuals and organizations who understand that funds invested in CCF operations, means advancement in research for years to come.







# Statement on variation between 2020 Annual Report financial estimates and 2020 audited financial statements

For 2020, the accounting firm retained by CCF used a percentage allocation to distribute functional expenses between program, general & administration, and fundraising in addition to direct programmatic expense (i.e., grant distribution). This allocation was a projected amount to each category based on what was done in 2019. The audit did not use these percentages and so any salary, fringe, technological and other expenses used to carry out program expenses were grouped in the overhead/fundraising categories.

2020 was an unprecedented year. Fewer funds were raised, fewer grants were extended, and the research symposium was canceled. Despite best efforts to minimize expenses, including a reduced salaries across the board, CCF had a higher percentage of overhead expenses to keep the organization in operation, such as loan applications and requesting emergency grant. This resulted in a less than ideal distribution between programmatic spending vs. overhead spending.

In years prior to 2020, and for 2021, the audit has aligned/will align more closely with the year-end financial statements from the accounting firm.
