The Children's Cancer Foundation, Inc. (CCF) is accepting proposals for its 2024 Research Grant Award for advancing pediatric cancer treatment and outcomes. Please share this Request for Proposals with investigators in your department as you think appropriate.

#### **About the CCF Research Award**

CCF welcomes meritorious laboratory and clinical research proposals relevant to pediatric cancer research. Grants will be awarded for a period of one year, beginning November 2024. The maximum award amount for a CCF Research Grant is \$75,000.

CCF provides grants in support of pediatric cancer research in the **Maryland/DC/Northern Virginia** area.

# Citizenship

At the time of application, candidates must be U.S. citizens, foreign nationals holding either a permanent resident (I-551 or Green Card) or a USCIS-issued I-551 temporary evidence stamp in one's passport, or foreign nationals with J1 or H1B visas that extend beyond the life of the grant. All foreign nationals must submit, with the application, notarized evidence of this status. At the time of application and throughout the award, an applicant must be employed by a U.S. institution.

### **Selection Process and Award Details**

Grant Proposals are reviewed by an independent Selection Committee. All submitted grants will receive a score and overall critique. Notification of Grant Award will be made by **August 2024**, and formal agreements will follow. Award checks will be presented to recipients at the CCF Gala on November 2, 2024.

The Selection Committee reserves the right to determine applicant's eligibility based on the information and justifications included in the application materials.

Applicants MAY be involved in other research grants, but there must be clear documentation of mechanisms to avoid scientific and/or budgetary overlap.

There will be multiple Research Grants awarded in 2024 with a maximum award amount of \$75,000. The Grant will be awarded for a period of one (1) year, but the Research Awardee is encouraged to apply for CCF funding in subsequent year(s.)







#### 2024 CCF Grant Submission Process

Please ensure that the following elements are included with the proposal:

- Cover Sheet (enclosed), completely filled out, including Department Chair signature,
- All appropriate Biosketches, and
- Current and pending Grant disclosure, particularly those with overlapping scientific aims.

# Requirements

The obligations of grant awardees after notification are:

- Submission of a two (2) page report within 90 days of grant end date.
- Attendance at the CCF Gala on November 2, 2024 at Martins Crosswinds in Greenbelt, MD to receive Award.
- Participation in the 9th Annual CCF Research Symposium with a presentation or poster. The tentative date is Wednesday, June 11, 2025.
- Award (check) is to be deposited promptly so that funds clear prior to December 31, 2024.
- Citation of CCF support in ALL relevant published material and notification to CCF of publications. Failure of citation may impact future funding eligibility.
